Advance Futurity Entries

Advance futurity entries are intended to expedite the entry process. **Futurity entries are due no later than August 15.** Please copy the entry forms, using one for each horse/ rider combination. Include copies of NRHA membership cards, non pro cards and competition licenses. Late entries will be assessed a \$50 late fee. **No Refunds on Futurity Entries will be made after August 15, 2007.**

Paid Warm-Ups

Paid warm-ups will be Thursday for \$20 for 5 minutes. For reservations, call Art Canright (913) 592-2055.

Competition Guidelines

1. NRHA approved (except green horse/rider) and NRHA rules apply.
2. Green Horse/Rider is open to horses/riders who have never won a breed or NRHA reining.
3. Post entries for the first class in AM will close at the conclusion of the last class of the preceding day. All other entries will close two classes prior.
4. Show committee to retain 50% of entry fees.
5. KRHA will mail payback checks after final verification by NRHA.
6. Horses multiple-entered in concurrent classes will pay only highest judge's fee.
7. Exhibitors competing for the high-point awards must show in both classes.
8. **A \$10 per horse Office Fee will be assessed.**
9. A \$3 per run Video Fee will be assessed.

Method of Payment

Exhibitors who have written insufficient funds checks at any past KRHA show must pay for stalls, paid warm-ups and entries with cash or a cashier's check.

Hospitality

Coffee and rolls served daily. Water stations will be situated throughout the stable and warm-up areas.

Lodging

KRHA has arranged for reduced room rates at the Capitol Plaza Hotel, which is adjacent to the Expocentre.

Move-In

Move-in begins at 8 a.m., Thursday, August 23. Volunteers will be on hand to assist you. Please be courteous to those behind you and park your trailers on the lot southeast of Domer Arena as soon as you finish unloading.

Stalls

240 stalls are available. PAYMENT IS REQUIRED BY AUGUST 1. Stalls are guaranteed only when payment is received.

Reserve stalls as soon as possible. If the number of stalls you have reserved changes, notify the stall manager immediately. We maintain a waiting list and will notify those on the list as openings occur.

All Stalls: \$120 – Includes 3 bags of shavings.

••Expocentre prohibits tie-outs.

Additional Shavings Purchases

The Expocentre requires all stalls to be bedded. Additional bags of shavings may be purchased.

Stall Fee Refunds

No stall refunds will be made after August 15, 2007.

Sunday Night Layovers

Please note: The Expocentre will require an additional \$17 for horses which lay over on Sunday night. Anyone who plans to use stalls Sunday night must make arrangements with the Expocentre personnel located in the office on the ground level of the main hall before the show concludes Sunday afternoon. The Expocentre staff padlocks stalls that have not been paid for.
