TERMS AND CONDITIONS

1. Mid America Equine Sales, LLC and its associates act as agent only on all sales, and are not responsible for buyer/seller error or misunderstanding.
2. Consignment forms must be accompanied by original registration papers and a signed transfer OR entry fee and a photocopy of the registration papers.
3. Individual NEGATIVE COGGINS TEST (original – not faxes or copies) current within 6 months and a Health Certificate current within 30 days must be provided day of sale.
4. Two Year Old Futurity prospects MUST be ridden through the sale's ring! (only exception Feb 2007 sale)!
5. Any defects or bad habits must be called when horse is presented in sale's ring. (Example: Cryptoids, Cribbers, Lameness or Unsoundness, Parrot Mouth, HYPP N/H or H/H, etc.).
6. Consignors will be paid within 5 banking days from day of sale.
7. ENTRY FEE is \$400 of which half will go to the purse for the 2008 Futurity of buyer's choice (Cutting, Reining, or Reined Cow Horse).

SALES COMMISSION is 8% of the final bid or minimum of \$400/maximum of \$1,500 (half of which will go to the purse for the 2008 Futurity).

PASS OUT FEE is 8% of the final bid or minimum of \$400/maximum of \$1,500 (half of which will go to the purse for the 2008 Futurity).
8. Buyer chooses which 2008 Futurity the horse is to be enrolled in by January 1, 2008. After January 1, 2008, a late designation fee of \$200 applies. The horse may be enrolled in an additional futurity for \$1,000.
9. The Entry Fee is non-refundable. Consignor agrees not to withdraw entry except for serious injury, sickness or death, and will furnish sales company with a notarized veterinary statement prior to day of sale. The Consignor of any horse withdrawn from sale, for any reason other than serious injury, sickness, or death, will be assessed a \$500 penalty IN ADDITION to the Entry Fee or 8% of the selling price, whichever is greater. That entry will not be eligible to show in the 2008 Futurity.
10. Upon execution of this contract, Consignor agrees not to sell the horse by private sale. All horses must go through the sale's ring. NO horses are to be sold prior to going to the sale's ring. (NO trading out back).
11. A \$5.00 halter charge will be deducted for every horse sold. A new halter will be given to the buyer when payment is made.
12. Transfer fees for all AQHA horses will be deducted from seller.
13. Only horses that are consigned to the sale will be allowed on the sale grounds. All other horses sold before, during, and after sale will be subject to 8% commission and an entry fee.
14. All entries shown in Non Pro Futurity must be registered in that person's name.
15. All horses are subject to a selection process.
